We adopted a new direct-service program, Pathways to Family Peace, which is a behavior change program for domestic violence offenders. Most of our participants are court-ordered to attend. We also provided trainings locally, nationally and internationally on facilitating men's nonviolence programs using video conference software.

4b (Code:) (Expenses \$ including grants of \$) (Revenue \$)

Due to COVID-19, we shifted our trainings and capacity building efforts to support partners remotely. Between March and August 2020, we hosted 13 webinars on a variety of topics related to protecting women's safety and promoting offender accountability during the pandemic. In August and September, we offered two 3-day trainings for professionals in Australia on Coordinated Community Response to violence against Women and Girls.

We were contracted by the UN Women Regional Office in Thailand to improve responses to violence against women and girls in the Asia and Pacific Islands region. We created a training package for prosecutors on domestic and sexual violence cases. We also provided expert commentary on a draft bill to protect women from violence during COVID-19 in the Philippines.
